WeGo proposes service changes for Spring 2022 *Public meetings scheduled for January 20, 25*

NASHVILLE – In a continuation of efforts to adjust public transit service in Nashville and Middle Tennessee in response to ridership needs and the ongoing COVID-19 pandemic, WeGo Public Transit will have an open public comment period starting Monday, January 10 through Monday, January 31, 2022.

During this time, customers will be able to view proposed service changes, participate in virtual meetings to provide comment directly to WeGo staff members, and submit feedback via mail, phone, and email as the agency works to ensure the changes proposed will meet the needs of the communities served.

New Proposed Spring Service Changes

The proposed spring service changes would feature the following adjustments:

More trips during weekday peaks

6 Lebanon Pike	19 Herman	29 Jefferson

17 12 th Avenue South		

Weekday Evening Frequency Improvements

3 West End/White Bridge	7 Hillsboro Pike
5 West End/Bellevue	8 8 th Avenue South

Additional trips in the late evening/night on weekdays, Saturdays, and Sundays

3 West End/White Bridge	50 Charlotte Pike	55 Murfreesboro Pike
22 Bordeaux	52 Nolensville Pike	56 Gallatin Pike
23 Dickerson Pike		

Weekend Frequency Improvements

6 Lebanon Pike	8 8 th Avenue South (Saturdays)
7 Hillsboro (Saturday and Sunday)	55 Murfreesboro Pike (Saturdays)

Expanded service hours:

- 6 Lebanon Pike – longer span of service on Saturdays and Sundays, with hourly service from 6 a.m. to 10 p.m.
- Access On Demand – extend hours to 8 p.m.

Route adjustments

- 4 Shelby – change routing from Gallatin Pike; no service on Ardee between Gallatin and Kennedy
- 76 Madison – change routing from Gallatin Pike; buses will pick up at Madison Station outbound and then continue via Gallatin Pike, Old Hickory Blvd, and Forest Park to Neely’s Bend
- 21 Wedgewood & 77 Thompson – combine as one route; extend from Tennessee State University 26th & Clarksville via Ed Temple Boulevard

New Routes

- 79 Skyline – new route connecting Dickerson Pike to Gallatin Pike and the 76 Madison

Rename/renumber

- 3 West End/White Bridge – combine with route 5 and rename 3 West End; White Bridge portion named 3A
- 5 West End/Bellevue – combine with route 3 and rename 3 West End; Bellevue portion named 3B
- 21 Wedgewood – combine with 77 Thompson and rename 77 Thompson/Wedgewood
- 25 Midtown – renumber to 75 Midtown
- 77 Thompson – combine with 21 Wedgewood and rename 77 Thompson/Wedgewood
