
Spring 2023 Better Bus Service Changes

 - » Access improvements




Spring 2023 - Span of Service Improvements

 - » Route 42 St Cecilia and Route 6 Lebanon extending until 11:15 p.m. seven days a week




Spring 2023 – Frequency Improvements

 - » Improving to every 30 minutes




Spring 2023 – Crosstown Improvements
